WORLD SKATE ACADEMY: SPEED

We are pleased to provide you with the information about the World Skate Academy for Speed **Judges** 2025 that will be held from **April 9 to April 26**. We are confident that this initiative will further enrich the development of the arbitration of this beautiful sport worldwide.

The program and contents are defined and managed by the Speed Technical Commission.

The Online Courses will be held through the World Skate Academy platform.

INTERNATIONAL AND NATIONAL JUDGES

The World Skate Academy will be training and updating the International Judges.

The National Judges are also welcome to register for the Courses with the objective of improving their officiating skills arbitrage and increasing the technical and disciplinary level of competitions to the highest.

Lessons are open to everyone.

The National Federations need to indicate the National Judges who will take part in the course by filling-in the Form available at the following <u>link</u>:

As per the Speed Rules, it is mandatory for the International Judges to attend the Academy (renewal at least every two years) and to take the final test in order to keep updated and to maintain the highest standards. International Judges not complying with this condition will lose their commission. They need to sign up and purchase the course (when available) directly on the platform:

Official International Judges will be eligible to officiate the World Skate Sanctioned events.



LESSONS AND SCHEDULE

The 2025 Judges course will be available to be purchased online from March 6 to April 18.

The course will start on **April 9** and will be available **until April 26**, after that date the course will not be accessible anymore. The Final Test will take place on **April 27** (two sessions available: 9:00 or 15:00 CET).

All lessons are pre-recorded and the Participants will be able to attend on the days and times of their choice, during the 2 weeks. All lessons will be available in English only.

For each lesson, the Participants will have access to a section on the platform called "Discussion" in which you will be able to share your doubts, comments and questions regarding the lesson you are attending.

At the end of this seminar, ALL Judges will receive a Certificate of Participation, which will be available directly in their profile on the Academy platform (in the "Certificates" section of "My Account" page).

Only the International Judges will take the Final Test on **April 27**. More information on the test will be available at a later stage.

ENTRY FEES

Following the cost of the Academy 2025 Course for Judges:

140 USD (includes 12 lessons).

REGISTRATION

The online courses will be carried out through the World Skate Academy platform.

All Participants who have not done it yet will have to register in the system individually and **not** through the National Federation.

The individual payment can be processed directly on the platform by PayPal. It will be



possible to pay via credit/debit card and no PayPal account is required.

Should National Federations need to pay the courses for their Participants, first they will need to send an email to academy@worldskate.org explaining which participants and which courses the payment should be made for; then they will be able to process the payment via bank transfer or credit/debit card through a direct link.
